1. Objectives

- 1. To federate (to instigate/coordinate) the International Korczak movement: place of exchanges, communication & dialogue enters associations main roads
- 2. To develop an international korczakian action in relation to other ONG relating to the defense and the child welfare (Cooperation R-2)
- 3. To imply rising generation in the life of movement (Rejuvenation R-4)

2. Actions

- 1. To create a Center international of research on the work of JK with two shutters:
 - a. Theory (R-1) Studies and publications
 - b. Practical (R-3) Inventory, analyzes and diffusion of various practices and korczakian applications in the various fields (educational and different)
- 2. To develop the documentary Center of resources international (Korczakianum)
- 3. To develop the means of working together (Network R-5)

3. Organisation and working procedure

Redefinition of the statutes and internal rules on a basis of real democracy and according to an ethics korczakian. The IKA will be the house of associations Korczak.

- Members = 1 association by country, bearing the name of Janusz Korczak
- 1 voice by association
- Place of exchanges (access and division of information)
- Mutualisation of resources, knowledge & the means (pooling)
- Solidarity, mutual aid enters the members, reception of new
- Resource Place
 - Free Access to the Korczak's materials in counterpart of an engagement of retrocession to the IKA of 50% on the rights and receipts
 - 1 annual General meeting (Parliament)
 - 1 newspaper (Newsletter)
 - 1 mural table (the website)
 - Etc. (also with possibility of management of the conflicts)

With (means of action)

Un dynamic Board (R-6 A team)

- -Members elected by the General meeting to which they give an account of their action
- With mandates and missions lights, revisable each year
- Working in team, in a collaborative way

Proposal for criteria for the candidates with the tasks of responsibility

- To know Well the history and the work of Janusz Korczak, to have read all the books of Korczak and articles published in its native language
- To commit itself working voluntarily for the IKA during at least a year
- To agree to work in team and to take part in collective projects and to organize itself for that (Internet, E-mail, telephone one IP, virtual meeting, etc)

Implied, equal members in their rights and engagements

(Conditions of membership with the IKA)

- Registrated Korczak Association main road of which the principal objective is the work of Janusz Korczak
- Functioning in way democratic and transparent
- Having a national action real
- Being able to give a copy of his annual report of activity and moral report with the IKA
- Paying a contribution annual fixed by the General meeting of the IKA
- meeting as an annual General meeting, controlling the activity of the Office
 - Voting rights reserved to up to date associations of their contribution
 - 1 maximum capacity by association present

Receipts various (R-7 Budget)

- Contributions of the members
 - Fixed each year by the General meeting
 - Always proportional to the budget of each member
 - In 2007 (1st year, probatory): minimum symbolic system for all: 10 euros.
- Contribution of the Swiss Korczak Foundation
- Receipts of the copyrights of the documents of or on Korczak (inventory)
- Search for subsidies
- Fundraising

Loads reduced

- No building in Warsaw, Geneva or Jerusalem
- A reduced Office, not of driver nor of car of function for the president but only one white blouse (gray) per annum
- Expenses of to the minimum reduced meeting and office thanks to the use of modern technologies of communication (Internet, virtual meetings, etc)
- A permanent control of the sums engaged for actions and projects voted in meetings.
